The Foundation for the Bethlehem Area School District, also known as the Bethlehem Area Education Foundation is a registered 501(c)(3) charitable organization with the identification number 23-2896860.

As financial and family circumstances differ widely, it's best to discuss your individual situation and goals with a qualified estate or tax attorney.

Will/Bequest

Bequest through a will, which specifies how a donor's property will be distributed after his or her death, is the most common type of planned gift. A bequest can indicate a specific dollar amount or asset, or it can assign a certain percentage of the donor's estate to The Foundation for the Bethlehem Area School District.

Charitable Remainder Trust

A charitable remainder trust allows a donor to donate assets while continuing to receive payments based on those assets.



Individual Retirement Account (IRA)

IRAs can be used as a charitable tool to start your legacy gift with The Foundation for the Bethlehem Area School District. Donors can name The Foundation for the BASD as the beneficiary of their IRA as a planned giving tool.

Life Insurance

Gifts of life insurance can help donors make a significant philanthropic impact and may also reduce or eliminate estate and income taxes for heirs. Gifts of life insurance allows you to take care of your family, and at the same time, fulfill your charitable legacy.

Charitable Gift Annuity

A charitable gift annuity enables donors to contribute assets to The Foundation for the Bethlehem Area School District, receive an income tax charitable deduction, and receive a guaranteed income for life.
